

RULES:

Your Summer Journey Sweepstakes OFFICIAL RULES June 27, 2011 – September 7, 2011

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: The Your Summer Journey Sweepstakes (the “**Sweepstakes**”) begins on or about June 27, 2011 at 12:01 a.m. Eastern Time (“**ET**”) and ends on September 7, 2011 at 11:59 p.m. ET (the “**Promotion Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Time Warner Cable Media, 815 Erie Boulevard East Syracuse, NY 13210 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal U.S. residents who are twenty-one (21) years of age or older and reside in the following Time Warner Cable: Buffalo, Rochester, Syracuse/Central, Binghamton, Albany, (New York State markets) and Augusta, Bangor, Lewiston, Portland, Presque Isle and York (Maine markets) are eligible to enter. Sponsor, Time Warner Cable Inc., Corning Museum of Glass, Finger Lakes Wine Country, and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize.

HOW TO ENTER:

Online Entry: To enter online, visit the web site www.yoursummerjourney.com (the “**Website**”), complete the entry form with the information requested, and click “Submit Entry”. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with the privacy policy found on the Website.

NOTE: Internet entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited.

Mail-In Entry: To enter by mail, hand print in ink on a 3" x 5" postcard your full name, complete home address and zip code, home telephone number and area code, date of birth, and e-mail address (if any). Mail this completed card in a first-class stamped envelope to: Your Summer Journey Sweepstakes, c/o Time Warner Cable Media, 815 Erie Boulevard East Syracuse, NY 13210. No metered mail will be accepted. All mail-in entries must be received by September 7, 2011. No copies, facsimiles or mechanical reproductions will be accepted. Sponsor assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible or postage due entries or mail. Limit one (1) entry per outer mailing envelope.

All entries, regardless of method of entry, must be received by the end of the Promotion Period in order to participate. The Website's database clock will be the official time keeper for online entries in this Sweepstakes. In the event of a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry may be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. Once submitted, all entries become the property of Sponsor and will not be returned. **Limit one (1) entry per person and/or per e-mail address regardless of method of entry.**

WINNER SELECTION AND NOTIFICATION: At the end of the Promotion Period, the potential prize winner will be randomly selected from all eligible entries received during the Promotion Period. The potential prize winner will be notified by telephone and/or mail and/or e-mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go un-awarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected. **The odds of winning depend on the number of eligible entries received.**

PRIZES/APPROXIMATE RETAIL VALUES:

One (1) Grand Prize is available. The Grand Prize consists of a \$250.00 prepaid gift card, a \$250 gas station gift card (retailer TBD at the sole discretion of Sponsor), and an ice Cooler. The Grand Prize also includes: two (2) nights hotel accommodations in Old Forge, NY (one room, up to quad occupancy); one (1) night mid-week hotel accommodation at the Holiday Inn Express in Horseheads, NY (one room, up to quad occupancy); six (6) day passes to the Corning Museum of Glass; two (2) "Make Your Own Glass" sessions at The Corning Museum of Glass; a \$50 Corning Museum of Glass Gift Card; two (2) day passes to the Rockwell Museum of Western Art; and a selection of wine tastings at select wineries along the Seneca Wine Trail (the "**Finger Lakes Wine Trail Package**"). Gift Cards may be subject to separate terms and conditions imposed by issuer. Exact accommodations are at the sole discretion of Sponsor. All components of the Grand Prize must be used within one (1) year of date prize is awarded, except for the accommodations in Horseheads, NY and Finger Lakes Wine Trail Package which must used before May 31, 2012. Accommodations are subject to certain restrictions and black out dates. Accommodations must be booked through Sponsor at least thirty (30) days in advance.
